TAKE NOTICE THAT the annual general and special meeting (the “**Meeting**”) of the holders of common shares (the “**Shareholders**”) in the capital of Overlord Financial Inc. (the “**Corporation**” or “**Overlord**”) will be held at the offices of Lavery de Billy, located at 1 Place Ville Marie, Bureau 4000, Montreal, Quebec on Wednesday, May 31, 2006 at the hour of 2:00 p.m. (Montreal time) for the following purposes:

1. To receive and consider the consolidated financial statements of the Corporation as at and for the financial year ended December 31, 2005, together with the report of the auditors thereon;
2. To fix the board of directors of the Corporation at six (6) members;
3. To elect directors of the Corporation for the ensuing year on the terms more particularly described in the Information Circular;
4. To appoint BDO Dunwoody LLP as auditors of the Corporation and to authorize the directors to fix the remuneration to be paid to the auditors;
5. To consider and, if thought fit, approve, with or without variation, an ordinary resolution, as more particularly set forth in the Information Circular relating to the approval of the Stock Option Plan of the Corporation; and
6. To transact such other business as may properly be brought before the Meeting, or any adjournment or postponement thereof.

INFORMATION CIRCULAR

INTRODUCTION

This Information Circular is furnished in connection with the solicitation by management of Overlord of proxies from the holders of Overlord Shares to be held at the offices of Lavery de Billy, located at 1 Place Ville Marie, Bureau 4000, Montreal, Quebec on Wednesday, May 31, 2006 at the hour of 2:00 p.m. (Montreal time), and at any adjournment thereof for the purposes set out in the accompanying Notice of Annual General and Special Meeting. Although it is expected that the solicitation of proxies will be primarily by mail, proxies may also be solicited personally or by telephone by directors or officers of the Corporation. Arrangements will also be made with clearing agencies, brokerage houses and other financial intermediaries to forward proxy solicitation material to the beneficial owners of Overlord Shares pursuant to the requirements of National Instrument 54-101 – *Communication with Beneficial Owners of Securities of a Reporting Issuer*. The cost of any such solicitation will be borne by the Corporation.

All capitalized terms used in this Information Circular not otherwise defined herein have the meanings set forth under the heading “*Glossary of Terms*”. Information contained in this Information Circular is given as of XX, 2006 unless otherwise specifically stated.

FORWARD-LOOKING STATEMENTS

This Information Circular contains forward-looking statements that reflect the current expectations of Overlord about Overlord’s future results, performance, prospects and opportunities. Overlord has tried to identify these forward-looking statements by using words such as “may,” “expect,” “anticipate,” “believe,” “intend,” “plan,” “estimate,” “potentially” and similar expressions. Such forward-looking statements necessarily involve known and unknown risks and uncertainties that may cause Overlord’s actual results, performance, prospects and opportunities in future periods to differ materially from those expressed or implied by such forward-looking statements. There can be no assurance that the expectations of Overlord will prove to be correct.

GLOSSARY OF TERMS

The following is a glossary of certain terms used in this Information Circular, and, unless otherwise indicated therein, in the Appendices to this Information Circular.

“**ABCA**” means the *Business Corporations Act* (Alberta), S.A. 2000, c. B-9 including the regulations promulgated thereunder;

“**affiliate**” or “**associate**” when used to indicate a relationship with a person or company, have the same meanings as set forth in the *Securities Act* (Alberta);

“**Board of Directors**” means the board of directors of Overlord;

“**Business Day**” means a day which is not a Saturday, Sunday or statutory holiday in the Province of Alberta;

“**By-Laws**” means the by-laws of Overlord;

“**Effective Date**” means the date of this Information Circular;

“**Information Circular**” means this information circular and all schedules hereto;

“**Instrument of Proxy**” means the form of proxy to be used by Shareholders in connection with the Meeting;

“**Meeting**” means the annual general and special meeting of Shareholders to be held on May 31, 2006 and any adjournment(s) thereof;

“**Notice of Meeting**” means the notice to the Shareholders of the Meeting, which notice accompanies the Information Circular;

“**Options**” means the stock options issued by Overlord entitling the holders thereof to acquire Overlord Shares;

“**Overlord**” means Overlord Financial Inc.;

“**Overlord Share**” or “**Shares**” means voting Class A Common Shares of Overlord as presently constituted;

“**person**” means any individual, partnership, association, body corporate, trustee, executor, administrator, legal representative, government, regulatory authority or other entity;

“**Record Date**” means the close of business on April 20, 2006;

“**Shareholders**” means the holders of Overlord Shares;

“**Stock Option Plan**” means the rolling stock option plan of Overlord approved by the shareholders on June 17, 2005, attached as Schedule “A”, for approval at the Meeting;

“**Subsidiary**” includes, with respect to any person, any other person that is controlled, directly or indirectly, by the person;

“**Transfer Agent**” means Computershare Trust Company of Canada at its principal offices in Calgary, Alberta, and Toronto, Ontario; and

“**TSX-V**” means the TSX Venture Exchange.

In this Information Circular, words importing the singular number also include the plural and vice versa and words importing any gender include all genders. Unless otherwise indicated in this Information Circular, all references to “dollars” and the symbol “\$” are to Canadian dollars.

GENERAL PROXY MATTERS

Solicitation of Proxies

All Overlord Shares represented at the Meeting by properly executed proxies will be voted or withheld from voting, as applicable, and where a choice with respect to any matter to be acted upon has been specified in the Instrument of Proxy, the Overlord Shares represented by the proxy will be voted in accordance with such specifications. **In the absence of any such specifications, the management designees, if named as proxy, will vote in favour of all the matters set out herein.**

The enclosed Instrument of Proxy confers discretionary authority upon the management designees, or other persons named as proxy, with respect to amendments to or variations of matters identified in the Notice of Meeting and any other matters which may properly come before the Meeting. At the date of this Information Circular, the Corporation is not aware of any amendments to, or variations of, or other matters which may come before the Meeting. In the event that other matters come before the Meeting, then the management designees intend to vote in accordance with the judgment of the management designees.

Proxies, to be valid, must be deposited at the office of the Transfer Agent of the Corporation, Computershare Trust Company of Canada, Proxy Department, 100 University Avenue, 9th Floor, Toronto, Ontario M5J 2Y1, not later than the close of business at least 48 hours, excluding Saturdays, Sundays and holidays, before the time of the Meeting or any adjournment thereof.

Appointment of Proxy

A Shareholder has the right to designate a person or company (who need not be a shareholder of the Corporation) to represent the Shareholder at the Meeting other than Claude Blanchet (President and Chief Executive Officer) or Larry W. Titley (Vice-President and Chief Financial Officer). Such right may be exercised by inserting in the blank space provided, the name of the person to be designated and deleting or crossing out therefrom the names of the management designees or by completing another proper instrument of proxy and, in either case, depositing the Instrument of Proxy with the Registrar and Transfer Agent of the Corporation, Computershare Trust Company of Canada, Proxy Department, 100 University Avenue, 9th Floor, Toronto, Ontario M5J 2Y1, not later than the close of business at least 48 hours, excluding Saturdays, Sundays and holidays, before the time of the Meeting or any adjournment thereof.

Revocation of Proxies

A Shareholder who has given a proxy may revoke it as to any matter upon which a vote has not already been cast pursuant to the authority conferred by the proxy. A proxy may be revoked by either executing a proxy bearing a later date or by executing a valid notice of revocation, either of the foregoing to be executed by the Shareholder or by his authorized attorney in writing, or, if the Shareholder is a corporation, under its corporate seal by an officer or attorney thereof duly authorized, and by depositing the proxy bearing a later date with the Transfer Agent, at any time up to and including the last business day preceding the date of the Meeting or any adjournment thereof at which the proxy is to be used or by depositing the revocation of proxy with the chairman of such Meeting on the day of the Meeting, or any adjournment thereof, or in any other matter permitted by law. In addition, a proxy may be revoked by the Shareholder personally attending at the Meeting and voting his Overlord Shares.

Advice to Non-Registered Shareholders

The information set forth in this section is of significant importance to Shareholders, as a substantial number of Shareholders do not hold Overlord Shares in their own name. Shareholders who do not hold their shares in their own name (referred to in this Information Circular as “**Beneficial Shareholders**”) should note that only proxies deposited by Shareholders whose names appear on the records of the Corporation as the registered holders of Overlord Shares can be recognized and acted upon at the Meeting. If Overlord Shares are listed in an account statement provided to a shareholder by a broker, then, in almost all cases, those Overlord Shares will not be registered in the shareholder’s name on the records of the Corporation. Such Overlord Shares will more likely be

registered under the name of the Shareholder's broker or an agent of that broker. In Canada, the vast majority of such shares are registered under the name of CDS & Co. (the nominee of The Canadian Depository for Securities Limited, which acts as depository for many Canadian brokerage firms). Overlord Shares held by brokers or their agents or nominees can only be voted upon the instructions of the Beneficial Shareholder. Without specific instructions, a broker and its agents and nominees are prohibited from voting shares for the broker's clients. **Therefore, Beneficial Shareholders should ensure that instructions respecting the voting of their Shares are communicated to the appropriate person.**

Applicable regulatory rules require intermediaries/brokers to seek voting instructions from Beneficial Shareholders in advance of the Meeting. Every intermediary/broker has its own mailing procedures and provides its own return instructions to clients, which should be carefully followed by Beneficial Shareholders in order to ensure that their Shares are voted at the Meeting. Often, the form of proxy supplied to a Beneficial Shareholder by its broker (or the agent of the broker) is identical to the form of proxy provided to registered shareholders. However, its purpose is limited to instructing the registered shareholder (the broker or agent of the broker) how to vote on behalf of the Beneficial Shareholder. The majority of brokers now delegate responsibility for obtaining instructions from clients to ADP Investor Communications ("ADP"). ADP typically applies a special sticker to the proxy forms, mails those forms to the Beneficial Shareholders and asks Beneficial Shareholders to return the proxy forms to ADP. ADP then tabulates the results of all instructions received and provides appropriate instructions respecting the voting of shares to be represented at a meeting. **A Beneficial Shareholder receiving a proxy with an ADP sticker on it cannot use that proxy to vote Overlord Shares directly at the Meeting. The proxy must be returned to ADP well in advance of the Meeting in order to have the Overlord Shares voted at the Meeting.**

Although a Beneficial Shareholder may not be recognized directly at the Meeting for the purposes of voting Overlord Shares registered in the name of his or her broker (or an agent of the broker), a Beneficial Shareholder may attend at the Meeting as proxyholder for the registered shareholder and vote the Shares in that capacity. Beneficial Shareholders who wish to attend the Meeting and indirectly vote their Shares as proxyholder for the registered shareholder, should enter their own names in the blank space on the form of proxy provided to them and return the same to their broker (or the broker's agent) in accordance with the instructions provided by such broker (or agent), well in advance of the Meeting.

Confidentiality of Voting

Proxies will be counted and tabulated by the Transfer Agent in such a manner as to preserve the confidentiality of your voting instructions, except:

- (a) where you make a written comment on the proxy form or otherwise clearly indicate that you wish to communicate your position to management;
- (b) as necessary to meet the requirements of applicable law or regulatory authorities; or
- (c) in the event of a proxy contest.

QUORUM

The By-Laws provide that holders present, not being less than two in number and holding or representing not less than twenty-five (25%) percent of the issued Overlord Shares entitled to vote at the Meeting, shall constitute a quorum for the Meeting in respect of Shareholders.

VOTING SHARES AND PRINCIPAL HOLDERS THEREOF

The Corporation is authorized to issue an unlimited number of Overlord Shares, of which 44,212,792 are issued and outstanding as at the date hereof.

Shareholders on record on the Record Date are entitled to vote their Overlord Shares at the Meeting on the basis of one vote for each Overlord Share held except to the extent that, (i) the holder transfers his or her Overlord Shares after the close of business on the Record Date, and (ii) such transferee produces properly endorsed share certificates to the Secretary or transfer agent of the Corporation or otherwise establishes his or her ownership of the Overlord Shares, at least ten days prior to the Meeting, in which case the transferee may vote those shares.

INFORMATION RELATING TO THE CORPORATION

Compensation of Executive Officers

During the financial year ended December 31, 2005, the Corporation employed two executive officers, whose aggregate cash compensation for services rendered in respect of such positions during such financial year was \$209,000, including salaries and bonuses. The bonuses paid in the most recently completed financial year include bonuses actually paid during and for the most recently completed financial year, bonuses to be paid for services rendered during the most recently completed financial year (unless those amounts have not yet been allocated), bonuses paid during the most recently completed financial year for services rendered in a previous financial year, and any compensation other than bonuses earned during the most recently completed financial year, the payment of which is deferred.

During the financial year ended December 31, 2005, the Corporation had two named executive officers, namely, Marcel J. Tremblay, Chairman and Chief Executive Officer from October 26, 2001 to December 29, 2005 and President from November 4, 2003 to December 29, 2005 and Larry W. Titley, Vice-President and Chief Financial Officer from November 4, 2003 to present (collectively, the "**Named Executive Officers**"). No other executive officers of the Corporation, or its subsidiaries, earned in excess of \$150,000 in total salary and bonuses during the financial year ended December 31, 2005.

Securities Authorized for Issuance under Equity Compensation Plans

A total of ten percent (10%) of the Overlord Shares outstanding from time to time are reserved for the issuance of stock options pursuant to the incentive stock option plan (the "**Plan**") of the Corporation approved by the shareholders on June 17, 2005. The Plan provides that the terms of the option and the option price shall be fixed by the directors subject to the price restrictions imposed by the TSX-V. The Plan also provides that no option shall be granted to any person except upon recommendation of the directors of the Corporation and only directors, officers, employees, consultants and other key personnel of the Corporation or its subsidiaries may receive stock options. Stock options granted under the Plan may not be for a period longer than five years and the exercise price must be paid in full upon exercise of the option.

As a requirement of the policies of the TSX-V the shareholders are being asked to approve the Stock Option Plan. See "*Particulars of Matters to be Acted upon - Approval of Stock Option Plan*".

The Corporation has no current equity compensation plans other than the Plan.

Stock Options

All Options held by the Named Executive Officers of the Corporation have been granted pursuant to the Plan.

The Corporation has not granted any stock appreciation rights or Options to the Named Executive Officers during the financial year ended December 31, 2005.

No Options were exercised by Named Executive Officers during 2005.

Long Term Incentive Plans

Other than the Plan, details of which are provided above, the Corporation does not have any long term incentive plans.

Other Compensation

The aggregate value of the other compensation (including benefits) paid by the Corporation to the Named Executive Officers of the Corporation did not exceed the lesser of \$50,000, and 10% of the annual salary paid to Named Executive Officers during the financial year ended December 31, 2005.

Employment Agreements

The Corporation entered into a Consultant Agreement with Ghost Lake Manor Inc., whereby Ghost Lake Manor Inc. provides consulting and investor relations services for projects and certain management services specifically, provided by Marcel Tremblay. Under the terms of the Consultant Agreement the Corporation will pay \$20,000 per month for services provided. Either party may terminate the Agreement upon ninety (90) days notice so long as such decision is not undertaken in bad faith. The Corporation has an Employment Agreement with Mr. Titley that may be terminated upon three (3) months notice. In the case of termination without cause or change of control, the Corporation is required to provide payments for a three (3) month period following termination.

Compensation of Directors

Other than being reimbursed by the Corporation for their expenses in attending meetings, there was no cash compensation paid to the directors of the Corporation for services rendered in their capacities as directors, during the financial year ended December 31, 2005. Directors have been granted Options to purchase Overlord Shares as described below.

The management of the Corporation is not aware of any material interest, direct or indirect, of any director, senior officer or any associate or affiliate of any of the foregoing persons, in any matter to be acted upon other than the election of directors.

Interest of Informed Persons in Material Transactions

The management of the Corporation is not aware of any material interest, direct or indirect, of any informed person or any proposed director of the Corporation or any associate or affiliate of any such person in any transaction since the commencement of its most recently completed financial year ended December 31, 2005, or in any proposed transaction, that has materially affected or would materially affect the Corporation or any of its subsidiaries.

For the purposes of this Information Circular, an “informed person” means (i) a director or officer of the Corporation, (ii) a director or officer of a person or company that is itself an informed person or (iii) any person or company who beneficially owns, directly or indirectly and/or exercises control or direction over voting securities of the Corporation carry more than 10% of the voting rights attaching to all outstanding voting securities of the Corporation.

CORPORATE GOVERNANCE DISCLOSURE

Overlord is a venture issuer (as defined in National Instrument 58-101 – *Disclosure of Corporate Governance Practices*) and is required to provide the following information in its Information Circular if Overlord is soliciting a proxy for the election of Directors.

Board of Directors

The Board of Directors facilitates its exercise of independent supervision over management by ensuring that the Board is composed of a majority of independent directors. After the Meeting, the Board will be composed of six (6) directors, four (4) of whom will be independent. Mr. Blanchet, the President and Chief Executive Officer of Overlord is not considered independent by virtue of the fact that he is an executive officer of the Corporation. Mr. Purdy is not considered to be independent as he Executive Vice President of Overlord and is the President of Juno Canada Holdings Ltd. and Sword Management Inc., each of which is a wholly owned subsidiary of Overlord.

The Board is responsible for approving long-term strategic plans and annual operating budgets recommended by management. Board consideration and approval is also required for material contracts and business transactions, and all debt and equity financings.

The Board delegates to management responsibility for meeting defined corporate objectives, implementing approved strategic and operating plans, carrying on the business of the Corporation in the ordinary course, evaluating new business opportunities and challenges, recruiting people and meeting all legal and regulatory requirements of the business.

Orientation and Continuing Education

The Board does not have any formal procedure to orient new board members nor does it have a formal policy of providing continuing education for directors. When a new director is appointed, they have the opportunity to meet the other directors, management and employees, with orientation tailored to the needs and experience of the new director, as well as the overall needs of the Board.

Overlord relies upon its professional advisors to update the knowledge of the board members in respect to changes in relevant policies and regulations. The Board expects to select any new members from persons who have the requisite knowledge and experience to ensure that the lack of formal policy will not detract from the performance of its members.

Ethical Business Conduct

The Board of Directors implemented a Corporate Code of Business Conduct and Conflict of Interest Policy to encourage and promote a culture of ethical business conduct, but, does rely upon the selection of persons as directors, officers and employees who they consider to meet the highest ethical standards.

Nominations of Directors

The Corporate Governance and Nomination Committee reviews potential nomination candidates as brought before the Committee by the Board of Directors. The Board as a whole is charged with the responsibility of identifying new candidates for board nomination. There are currently no formal procedures in place for identifying new candidates.

Compensation

The directors of Overlord do not receive any compensation for the performance of their duties as directors of the Corporation but do receive reimbursement for expenses incurred in attending meetings. Periodically, the directors receive grants of stock options, pursuant to the Plan. The Board, on recommendation of the Compensation Committee, is responsible for determining all forms of compensation to be granted to the President and Chief Executive Officer and the directors, and for reviewing the President and Chief Executive Officer's recommendations respecting compensation of the other senior executives of the Corporation. In this regard, the Board considers,

among other things, that recruitment and retention of qualified executives is critical to the Corporation's success, that compensation must be fair and competitive and that performance needs to be rewarded. The compensation paid to executive officers consists of a combination of base salary, performance incentives and options.

Other Board Committees

The Board does not have any standing committee other than the audit committee, compensation committee and the governance and nomination committee.

Assessment

The Board has not adopted formal procedures for assessing its effectiveness, nor that of its committees.

AUDIT COMMITTEE

The Audit Committee's Charter

Mandate

The primary function of the audit committee (the "**Committee**") is to assist the Board of Directors in fulfilling its financial oversight responsibilities by reviewing the financial reports and other financial information provided by the Corporation to regulatory authorities and shareholders, the Corporation's systems of internal controls regarding finance and accounting and the Corporation's auditing, accounting and financial reporting processes. Consistent with this function, the Committee will encourage continuous improvement of, and should foster adherence to, the Corporation's policies, procedures and practices at all levels. The Committee's primary duties and responsibilities are to:

- Serve as an independent and objective party to monitor the Corporation's financial reporting and internal control system and review the Corporation's financial statements.
- Review and appraise the performance of the Corporation's external auditors.
- Provide an open avenue of communication among the Corporation's auditors, financial and senior management and the Board of Directors.

Composition

The Committee shall be comprised of three directors as determined by the Board of Directors, the majority of whom shall be free from any relationship that, in the opinion of the Board of Directors, would interfere with the exercise of his or her independent judgment as a member of the Committee.

At least one member of the Committee shall have accounting or related financial management expertise. All members of the Committee that are not financially literate will work towards becoming financially literate to obtain a working familiarity with basic finance and accounting practices. For the purposes of Overlord's Charter, the definition of "financially literate" is the ability to read and understand a balance sheet, an income statement and a cash flow statement. The definition of "accounting or related financial management expertise" is the ability to analyze and interpret a full set of financial statements, including the notes attached thereto, in accordance with Canadian generally accepted accounting principles.

The members of the Committee shall be elected by the Board of Directors at its first meeting following the annual shareholders' meeting. Unless a Chair is elected by the full Board of Directors, the members of the Committee may designate a Chair by a majority vote of the full Committee membership.

Meetings

The Committee shall meet at least twice annually, or more frequently as circumstances dictate. As part of its job to foster open communication, the Committee should meet at least annually with the Chief Financial Officer and the external auditors in separate sessions.

Responsibilities and Duties

To fulfill its responsibilities and duties, the Committee shall:

Documents/Reports Review

- (a) Review and update this Charter annually.
- (b) Review the Corporation's financial statements, MD&A and any annual and interim earnings, press releases before the Corporation publicly discloses this information and any reports or other financial information (including quarterly financial statements), which are submitted to any governmental body, or to the public, including any certification, report, opinion, or review rendered by the external auditors.

External Auditors

- (a) Review annually, the performance of the external auditors who shall be ultimately accountable to the Board of Directors and the Committee as representatives of the shareholders of the Corporation.
- (b) Obtain annually, a formal written statement of external auditors setting forth all relationships between the external auditors and the Corporation, consistent with Independence Standards Board Standard 1.
- (c) Review and discuss with the external auditors any disclosed relationships or services that may impact the objectivity and independence of the auditors.
- (d) Take, or recommend that the full Board of Directors take, appropriate action to oversee the independence of the external auditors.
- (e) Recommend to the Board of Directors the selection and, where applicable, the replacement of the external auditors nominated annually for shareholder approval.
- (f) At each meeting, consult with the external auditors, without the presence of management, about the quality of the Corporation's accounting principles, internal controls and the completeness and accuracy of the Corporation's financial statements.
- (g) Review and approve the Corporation's hiring policies regarding partners, employees and former partners and employees of the present and former external auditors of the Corporation.
- (h) Review with management and the external auditors the audit plan for the year-end financial statements and intended template for such statements.
- (i) Review and pre-approve all audit and audit-related services and the fees and other compensation related thereto, and any non-audit services, provided by the Corporation's external auditors. The pre-approval requirement is waived with respect to the provision of non-audit services if:
 - (i) the aggregate amount of all such non-audit services provided to the Corporation constitutes not more than five percent of the total amount of revenues paid by the

Corporation to its external auditors during the fiscal year in which the non-audit services are provided;

- (ii) such services were not recognized by the Corporation at the time of the engagement to be non-audit services; and
- (iii) such services are promptly brought to the attention of the Committee by the Corporation and approved prior to the completion of the audit by the Committee or by one or more members of the Committee who are members of the Board of Directors to whom authority to grant such approvals has been delegated by the Committee.

Provided the pre-approval of the non-audit services is presented to the Committee's first scheduled meeting following such approval such authority may be delegated by the Committee to one or more independent members of the Committee.

Financial Reporting Processes

- (a) In consultation with the external auditors, review with management the integrity of the Corporation's financial reporting process, both internal and external.
- (b) Consider the external auditors' judgments about the quality and appropriateness of the Corporation's accounting principles as applied in its financial reporting.
- (c) Consider and approve, if appropriate, changes to the Corporation's auditing and accounting principles and practices as suggested by the external auditors and management.
- (d) Review significant judgments made by management in the preparation of the financial statements and the view of the external auditors as to appropriateness of such judgments.
- (e) Following completion of the annual audit, review separately with management and the external auditors any significant difficulties encountered during the course of the audit, including any restrictions on the scope of work or access to required information.
- (f) Review any significant disagreement among management and the external auditors in connection with the preparation of the financial statements.
- (g) Review with the external auditors and management the extent to which changes and improvements in financial or accounting practices have been implemented.
- (h) Review any complaints or concerns about any questionable accounting, internal accounting controls or auditing matters.
- (i) Review certification process.
- (j) Establish a procedure for the confidential, anonymous submission by employees of the Corporation of concerns regarding questionable accounting or auditing matters.

Other

The Committee will review any related party transactions.

Composition of the Audit Committee

The following members comprise the Committee:

Michael Fabi⁽²⁾⁽³⁾ Independent ⁽¹⁾ Financially literate ⁽¹⁾

Mr. Fabi has over 22 years experience in exploitation, engineering, evaluations, reserves determination, business development and acquisitions and divestitures. Mr. Fabi has been employed in various technical and management positions for such companies as Andex Oil Ltd., Enron Canada Ltd., DeKalb Energy Canada Ltd. and Apache Canada Ltd.

Jean Desmarais⁽³⁾ Independent ⁽¹⁾ Financially literate ⁽¹⁾

Mr. Desmarais, Vice President and Branch Manager of Desjardins Securities oversees financial advisors in addition to managing assets for institutional clients and retail investors. Prior to his current position, Mr. Desmarais was Investment Advisor for Nesbitt Burns. Mr. Desmarais graduated from the University of Montreal's Hautes Etudes Commerciales/Commerce program and is licensed with the Investment Dealers Association.

Financial Statements

The financial statements of Overlord for the financial year ended December 31, 2005 will be put before the Shareholders at the Meeting. The Board of Directors has approved these audited consolidated financial statements.

Number of Directors

For this forthcoming year, it is proposed that the board of directors shall consist of six (6) members. Management therefore intends to place before the Meeting, for approval, with or without modification, a resolution fixing the board of directors at six (6) members for the next ensuing year. Given the status of the Corporation and its ongoing needs, the number of directors of the Corporation may need to be revised accordingly.

Election of Board of Directors

It is proposed that the persons named below will be nominated at the Meeting. Each director elected will hold office until the next annual meeting of shareholders or until his successor is duly elected or appointed pursuant to the By-Laws unless his office is earlier vacated in accordance with the provisions of the ABCA or the By-Laws. **It is the intention of the management designees, if named as proxy, to vote for the election of said persons to the Board of Directors. Management does not contemplate that any of such nominees will be unable to serve as directors; however, if, for any reason any of the proposed nominees do not stand for election or are unable to serve as such, proxies in favour of management designees will be voted for another nominee in their discretion unless the shareholder has specified in his or her proxy that his or her shares are to be withheld from voting in the election of directors.**

The Corporation has implemented the Plan. Directors, officers, consultants and employees of Overlord may participate in the Plan. The purpose of the Plan is to provide the participants with an opportunity to purchase Overlord Shares and to benefit from the appreciation thereof. This will provide an increased incentive for the participants to contribute to the future success and prosperity of Overlord, thus enhancing the value of the Overlord Shares for the benefit of all the shareholders and increasing the ability of Overlord and its subsidiaries to attract and retain individuals of exceptional skill.

At the meeting of Shareholders held on June 17, 2005, the Shareholders approved an amendment to the Plan to provide that the maximum number of Overlord Shares reserved for issuance under the Plan shall be the number equal to 10% of the number of issued and outstanding Overlord Shares (on an undiluted basis) from time to time.

For further particulars of the Plan, see the copy of the Plan attached hereto as Schedule "A" to this Information Circular. The rules of the TSX-V require Overlord to put the Plan before the Shareholders for re-approval every year.

The text of the ordinary resolution to be considered at the Meeting approving the Plan is set forth below:

"BE IT RESOLVED as an ordinary resolution of the Corporation as follows:

- 1. the Corporation's Stock Option Plan (the "Plan") as approved by the Board of Directors is hereby approved, confirmed and ratified;**
- 2. the form of the Plan may be amended in order to satisfy the requirements or requests of any regulatory authorities without requiring further approval of the shareholders of the Corporation;**
- 3. any officer or director of the Corporation be and is hereby authorized to execute all such deeds, documents and other writings and perform such acts as may be necessary in order to give effect to the Plan as herein contemplated and the Board of Directors from time to time is authorized to grant options in the capital stock of the Corporation pursuant to and in accordance with the Plan, as amended; and**
- 4. the Corporation is authorized to reserve and issue Overlord Shares in the capital of the Corporation for issuance upon exercise of stock options granted pursuant to the Plan."**

The management designees, if named as proxy, intend to vote the Overlord Shares represented by any such proxy in favour of the resolution approving the Plan.

Other Business

While there is no other business other than that mentioned in the Notice of Meeting to be presented for action by the shareholders at the Meeting, it is intended that the proxies hereby solicited will be exercised upon any other matters and proposals that may properly come before the Meeting, or any adjournment(s) thereof, in accordance with the discretion of the persons authorized to act thereunder.

GENERAL

All matters to be brought before the Meeting require for the passing of same by way of an "ordinary resolution", being a simple majority of the votes cast in person or by proxy at the Meeting by the holders of Overlord Shares.

The contents and the sending of this Information Circular have been approved by the Board of Directors of the Corporation as of the Effective Date.

SCHEDULE "A"

OVERLORD FINANCIAL INC. STOCK OPTION PLAN

1. The Plan

This stock option plan (the "Plan"), pursuant to which options ("Options") to purchase common shares ("Shares") in the capital of Overlord Financial Inc. (the "Corporation") may be granted to the directors, officers, employees and consultants of the Corporation or of any of its subsidiaries or any other person or company engaged to provide ongoing management or consulting services to the Corporation or for any entity controlled by the Corporation, is hereby established on the terms and conditions herein set forth.

2. Purpose

The purpose of this Plan is to advance the interests of the Corporation by permitting, through the grant and exercise of Options, the directors, officers, employees and consultants of the Corporation or of its subsidiaries or any other person or company engaged to provide ongoing management or consulting services to the Corporation or for any entity controlled by the Corporation, to acquire Shares, thereby (i) increasing the proprietary interests of such persons in the Corporation, (ii) aligning the interests of such persons with the interests of the Corporation's shareholders generally, (iii) encouraging such persons to remain associated with the Corporation, and (iv) furnishing such persons with an additional incentive in their efforts on behalf of the Corporation.

3. Administration

- (a) This Plan shall be administered by the board of directors of the Corporation (the "Board").
- (b) Subject to the terms and conditions set forth herein, the Board is authorized to provide for the granting, exercise and method of exercise of Options, all on such terms (which may vary between Options granted from time to time) as it shall determine. In addition, the Board shall have the authority to: (i) construe and interpret this Plan and all option agreements entered into hereunder, (ii) prescribe, amend and rescind rules and regulations relating to this Plan (subject to regulatory approval, if necessary) and (iii) make all other determinations necessary or advisable for the administration of this Plan. All determinations and interpretations made by the Board shall be binding on all Participants (as hereinafter defined) and on their legal, personal representatives and beneficiaries.
- (c) Notwithstanding the foregoing or any other provision contained herein, the Board shall have the right to delegate the administration and operation of this Plan, in whole or in part, to a committee of the Board or to the President or any other officer of the Corporation. Whenever used herein, the term "Board" shall be deemed to include any committee or officer to which the Board has, fully or partially, delegated the administration and operation of this Plan pursuant to this Section 3.
- (d) Options to purchase the Shares granted hereunder shall be evidenced by an agreement, signed on behalf of the Corporation and by the person to whom an Option is granted, which agreement shall be in such form as the Board shall approve or authorize from time to time.

4. Shares Subject to Plan

- (a) Subject to Section 16 below, the securities that may be acquired by Participants under this Plan shall consist of authorized but unissued Shares. Whenever used herein, the term "Shares" shall be deemed to include any other listed securities that may be acquired by a Participant upon the exercise of Options held by such Participant the terms of which have been modified in accordance with Section 15 below.

- (b) The maximum number of Shares reserved for issuance under this Plan shall be the number equal to 10% of the number of issued and outstanding Shares (on an undiluted basis) of the Corporation from time to time. This prescribed maximum may be subsequently increased to any other specified amount, provided the change is authorized by a vote of the shareholders of the Corporation.
- (c) If any Options granted under this Plan shall expire, terminate or be cancelled for any reason without having been exercised in full, any unpurchased Shares to which such Options relate shall be available for the purposes of the granting of further Options under this Plan.

5. Maintenance of Sufficient Capital

The Corporation shall at all times during the term of this Plan ensure that the number of Shares it is authorized to issue shall be sufficient to satisfy the requirements of this Plan.

6. Eligibility and Participation

- (a) The Board may, in its discretion, select any of the following persons to participate in this Plan:
 - (i) directors of the Corporation or its subsidiaries;
 - (ii) officers of the Corporation or its subsidiaries;
 - (iii) employees of the Corporation or its subsidiaries; and
 - (iv) any other person or company engaged to provide ongoing management or consulting services for the Corporation or its subsidiaries provided such person or company performed and/or continues to perform services on an ongoing basis or is expected to provide a service of value to the Corporation or its subsidiaries,

(any such person having been selected for participation in this Plan by the Board is herein referred to as a "Participant"). The Corporation represents that directors, officers employees and consultants granted Options under this Plan are bona fide directors, officers, employees or consultants of the Corporation.

- (b) The Board may from time to time, in its discretion, grant Options to any Participant, upon such terms, conditions and limitations as the Board may determine, including the terms, conditions and limitations set forth herein, provided that Options granted to any Participant shall be approved by the shareholders of the Corporation if the rules of the TSX Venture Exchange (the "TSX") or any other stock exchange or exchanges on which the Shares are listed require such approval.

7. Exercise Price

- (a) Options may be exercised at a price (the "Exercise Price") which shall be fixed by the Board at the time that Options are granted. No Options shall be granted with an Exercise Price at a discount to the Market Price (as hereinafter defined).
- (b) The "Market Price" shall be the closing market price of the Shares on the TSX on the first day preceding the date of grant on which at least one board lot of Shares traded on the TSX.

8. Number of Optioned Shares

The number of Options granted to a Participant shall be determined by the Board as at the time the Options are granted, provided that: (i) the aggregate number of Shares reserved for issuance to any one Participant pursuant to the Options held by such Participant under this Plan or any other plan of the Corporation, shall not exceed 5% of the total number of issued and outstanding Shares (calculated on a non-diluted basis); (ii) Options granted to a

Participant who is a consultant shall not exceed 2% of the issued and outstanding Shares (calculated on a non-diluted basis) in any twelve month period, and (iii) Options granted to a Participant who is an employee engaged in investor relations activities shall not exceed 2% of the issued and outstanding Shares (calculated on a non-diluted basis) in any twelve month period, unless the Corporation receives the permission of the TSX or any other stock exchange or exchanges on which the Shares are listed to exceed such thresholds.

9. Term

The period during which Options may be exercised (the "Option Period") shall be determined by the Board at the time the Options are granted, subject to any vesting limitations which may be imposed by the Board in its sole, unfettered discretion at the time such Options are granted, provided that:

- (a) no Option shall be exercisable for a period exceeding five (5) years from the date the Option is granted unless otherwise specifically provided by the Board, and in any event, no Option shall be exercisable for a period exceeding ten (10) years from the date the Option is granted;
- (b) Options granted to a Participant who is engaged in investor relations activities must expire within 30 days after the Participant ceases to be employed to provide investor relations activities;
- (c) the Option Period shall be automatically reduced in accordance with Sections 11 and 12 below upon the occurrence of any of the events referred to therein; and
- (d) no Option in respect of which shareholder approval is required under the rules of the TSX or any other stock exchange or exchanges on which the Shares are then listed shall be exercisable until such time as the Option has been approved by the shareholders of the Corporation.

10. Method of Exercise of Options

- (a) Except as set forth in Sections 11 and 12 below or as otherwise determined by the Board, no Option may be exercised unless the holder of such Option is, at the time the Option is exercised, a Participant as defined in Section 6 above.
- (b) Options may be exercised in whole or in part and may be exercised on a cumulative basis where a vesting limitation has been imposed at the time of grant.
- (c) Any Participant (or his legal, personal representative) wishing to exercise an Option shall deliver to the Corporation, at its principal office in the City of Calgary, Alberta:
 - (i) a written notice expressing the intention of such Participant (or his legal, personal representative) to exercise his Option and specifying the number of Shares in respect of which the Option is exercised; and
 - (ii) in the case an Option is exercised, a cash payment, cheque or bank draft, representing the full purchase price of the Shares in respect of which the Option is exercised.
- (d) Upon the exercise of an Option as aforesaid, the Corporation shall use its reasonable efforts to forthwith deliver, or cause the registrar and transfer agent of the Shares to deliver, to the relevant Participant (or his legal, personal representative) or to the order thereof, a certificate representing the aggregate number of fully paid and non-assessable Shares as the Participant (or his legal, personal representative) shall have then paid for.

11. Ceasing to be a Director, Officer, Employee or Consultant

- (a) If any Participant who is a director, officer, employee or consultant of the Corporation or any of its subsidiaries shall cease to be a director, officer, employee or consultant of the Corporation or any

of its subsidiaries for any reason other than death, permanent disability or normal retirement, his Options will terminate immediately as to the then unvested portion thereof and at 5:00 p.m. (Calgary time) on the earlier of the date of the expiration of the Option Period and the ninetieth (90th) day after the date such Participant ceases to be a director, officer, employee or consultant of the Corporation or any of its subsidiaries as to the then vested portion of the Option.

- (b) Any termination of a Participant's employment for any reason shall occur on the date the Participant ceases to perform services for the Corporation or any Affiliate without regard to whether the Participant continues thereafter to receive any compensatory payment therefrom or is paid salary in lieu of notice of termination.
- (c) Neither the selection of any person as a Participant nor the granting of any Options to any Participant under this Plan shall (i) confer upon such Participant any right to continue as a director, officer, employee or consultant of the Corporation any of its subsidiaries, as the case may be, or (ii) be construed as a guarantee that the Participant will continue as a director, officer, employee or consultant of the Corporation or any of its subsidiaries, as the case may be.

12. Death, Permanent Disability or Normal Retirement of a Participant

In the event of the death, permanent disability or normal retirement of a Participant, any Options previously granted to him shall be exercisable until the end of the Option Period or until the expiration of 12 months after the date of death, permanent disability or normal retirement of such Participant, whichever is earlier, and then, in the event of death or permanent disability, only:

- (a) by the person or persons to whom the Participant's rights under the Options shall pass by the Participant's will or applicable law; and
- (b) to the extent that he was entitled to exercise the Options as at the date of his death or permanent disability.

13. Change of Control

Notwithstanding the provisions of Section 10, in the event of a sale by the Corporation of all or substantially all of its assets or in the event of a change of control of the Corporation then the Participant shall be entitled to exercise in full or in part any unexercised Options previously granted to him hereunder, whether vested or not, either during the term of the Options or within ninety (90) days after the date of termination of the employment of the Participant with the Corporation or any of its subsidiaries or the cessation or termination of the Participant as a director, officer or consultant of the Corporation or any of its subsidiaries, whichever first occurs.

For the purpose of this Agreement change of control of the Corporation means or shall be deemed to have occurred if and when:

- (a) the acceptance by the holders of shares of the Corporation, representing in the aggregate more than thirty-five (35%) percent of all issued and voting Shares of the Corporation, of any offer, whether by way of a takeover bid or otherwise, for all or any of the Shares of the Corporation; or
- (b) the acquisition, by whatever means (including, without limitation, amalgamation, arrangement, consolidation or merger), by a person (or two or more persons who in such acquisition have acted jointly or in concert or intend to exercise jointly or in concert any voting rights attaching to the Shares acquired), directly or indirectly, of the beneficial ownership of such number of voting Shares or rights to voting Shares of the Corporation, which together with such person's then owned voting Shares and rights to acquire voting Shares, if any, represent (assuming the full exercise of such rights to acquire voting Shares) more than thirty-five (35%) percent of the combined voting rights of the Corporation's then outstanding voting Shares, together with the

voting Shares that would be outstanding on the full exercise of the rights to acquire voting Shares and such person's previously owned rights to acquire voting Shares; or

- (c) the entering into of any agreement by the Corporation to merge, consolidate, amalgamate, initiate an arrangement or be absorbed by or into another company; or
- (d) the passing of a resolution by the Board or shareholders of the Corporation to substantially liquidate its assets or wind-up its business or significantly rearrange its affairs in one or more transactions or series of transactions or the commencement of proceedings for such a liquidation, winding-up or re-arrangement (except where such re-arrangement is part of a bona fide reorganization of the Corporation in circumstances where the business of the Corporation is continued and where the shareholdings remain substantially the same following the re-arrangement as existed prior to the re-arrangement); or
- (e) individuals who were members of the Board of the Corporation immediately prior to a meeting of the shareholders of the Corporation involving a contest for, or an item of business relating to the election of directors, shall not constitute a majority of the board of directors following such election.

14. Transferability

All benefits, rights and Options accruing to any Participant in accordance with the terms and conditions of this Plan shall not be transferable or assignable unless specifically provided herein. The Corporation shall not recognize any attempted exercise of any purported assignee of a Participant. During the lifetime of a Participant, any Options granted hereunder may only be exercised by the Participant and in the event of the death or permanent disability of a Participant, by the person or persons to whom the Participant's rights under the Options pass by the Participant's will or applicable law.

15. Amendment and Termination of Plan

The Board may, at any time, suspend or terminate this Plan. The Board may also at any time amend or revise the terms of this Plan, subject to regulatory approval provided that no such amendment or revision shall alter the terms of any Options theretofore granted under this Plan.

16. Amend or Cancel Options

With the consent in writing of the affected Participant, the Board may at any time:

- (a) renegotiate and amend the terms and conditions of any Option previously granted under this Plan, including without limitation the Option price, the number of Common Shares in respect of which the Option may be exercised, and the term of the Option; or
- (b) cancel any Option previously granted under the Plan;

provided that regarding an amendment of any Option:

- (c) the amended terms and conditions of the Option are consistent with the Plan's provisions;
- (d) if required, the Exchange approves the amendment of the Option; and
- (e) if the Participant is an Insider of the Corporation at the time of the amendment, the Corporation obtains the approval of its disinterested shareholders, if required by the TSX or any other stock exchange or exchanges on which the shares are listed.

The Board may grant, at its discretion, concurrently with or from time to time after the amendment or cancellation of an Option, one or more other Options to the Participant whose Option was amended or cancelled in accordance with this section 1.6.

17. Necessary Approvals

- (a) The obligation of the Corporation to issue and deliver Shares in accordance with this Plan is subject to applicable securities legislation and to the receipt of any approvals that may be required from any regulatory authority or stock exchange having jurisdiction over the securities of the Corporation. If Shares cannot be issued or paid to a Participant upon the exercise of an Option for any reason whatsoever, the obligation of the Corporation to issue such Shares shall terminate and any funds paid to the Corporation in connection with the exercise of such Option will be returned to the relevant Participant as soon as practicable.
- (b) No Options shall be granted pursuant to the Plan without obtaining the approval of the shareholders of the Corporation in accordance with the applicable rules, if any, of the TSX and any other stock exchange or exchanges on which the Shares are listed, if such grant together with grants pursuant to all other share compensation arrangements of the Corporation could result, at any time, in:
 - (i) a number of Shares reserved for issuance pursuant to Options granted to insiders exceeding ten percent (10%) of the outstanding issue;
 - (ii) the issuance within a one year period, of a number of Shares exceeding ten percent (10%) of the outstanding issue; or
 - (iii) the issuance to any one insider and such insider's associates, within a one-year period, of a number of Shares exceeding five percent (5%) of the outstanding issue.

Where used in this Section 16, the terms "insiders", "outstanding issue" and "associates" shall have the meanings attributed thereto in the rules of the TSX.

18. Stock Exchange Rules

This Plan and any option agreements entered into hereunder shall comply with the requirements from time to time of the TSX and any other stock exchange or exchanges on which the Shares are listed.

19. Right to Issue Other Shares

The Corporation shall not by virtue of this Plan be in any way restricted from declaring and paying stock dividends, issuing further Shares, varying or amending its share capital or corporate structure or conducting its business in any way whatsoever.

20. Notice

Any notice required to be given by this Plan shall be in writing and shall be given by registered mail, postage prepaid or delivered by courier or by facsimile transmission addressed, if to the Corporation, at its principal address in Calgary, Alberta, Attention: the President; or if to a Participant, to such Participant at his address as it appears on the books of the Corporation or in the event of the address of any such Participant not so appearing then to the last known address of such Participant; or if to any other person, to the last known address of such person.

21. Gender

Whenever used herein words importing the masculine gender shall include the feminine and neuter genders and vice versa.

22. Interpretation

This Plan will be governed by and construed in accordance with the laws of the Province of Alberta.
